Concept Note

The Adriatic Sea has always been an important component of the history, culture and economy of Italy and Croatia. It has also been the object of shared interests that tied together the two neighbours, as testified by the recent agreement on the demarcation of their respective exclusive economic zones and the trilateral cooperation in the Adriatic Sea between Italy, Croatia and Slovenia.

At the time when urban development, pollution, rising global temperatures and the overexploitation of natural resources pose increasing threats to the marine ecosystems, it is important to act together to protect and preserve the marine environment. The Interreg Italy-Croatia Cross-Border Programme 2014-2020 made a substantial contribution to the shared goal to put in place a system that would at the same time conserve the marine and freshwater environments and promote a sustainable economic development. The new 2021-2027 Programme will focus even more on blue economy, in particular by promoting green and blue innovation opportunities and cross-border solutions in the field of mobility, tourism and the protection of natural assets. Together with other EU-funded programmes focusing on blue economy in the Adriatic and Mediterranean Sea, these projects provide a platform for strengthening even further partnerships and collaborative action between Italian and Croatian public and private stakeholders in scientific research, innovation processes and economic development.

The event organised by this Embassy of Italy in Zagreb, as a contribution to this platform, will focus on some of the most important aspects of blue economy: development and use of innovative technology in the study and conservation of marine ecosystems.
